### A MESSAGE ON COVID-19 FROM STATE SURGEON ADAM WALLACE

#### Comrades,

I am writing this to inform you of some important facts and precautions that should be taken during the time of this global pandemic. Please forward and share this email with all of your VFW members.

First and foremost, I encourage everyone to visit <u>cdc.gov/coronavirus/2019-ncov/</u> <u>index.html</u> to read CDC's recommendations and to stay up to date on information about COVID-19. Also for Wisconsin specific information, please visit <u>dhs.wisconsin.gov/</u> <u>covid-19/index.htm</u> for further information and updates.

What is COVID-19? COVID-19 (commonly referred to as the coronavirus) is a viral respiratory illness. According to the CDC, it is spread between individuals who are in close contact with one another (within 6 feet). *The symptoms of COVID-19 are fever, coughing, and shortness of breath.* 

Who is most at risk? According to the CDC, the people with a higher risk of getting severely ill from COVID-19 are older adults, specifically those over the age of 60. People with serious chronic medical conditions like heart disease, diabetes, and lung disease are also at higher risk. A majority of the Wisconsin VFW population fits into the highest risk category of serious illness from COVID-19, which is why I recommend an abundance of caution be taken to protect all of our members.

**Mass Gatherings:** Current recommendations from the Wisconsin Department of Health Services (DHS) states that mass gatherings of 250 people or more should be canceled. Many VFW Posts across the state hold gatherings this size, especially during this time of the year as spring is approaching. I encourage all Posts to adhere to Wisconsin DHS recommendations.

As for large gatherings of fewer than 250 people, WI DHS recommends you **consider the importance of the event.** Does it provide an essential service? Is it necessary for the public? What negative consequences are there if the event does not take place? WI DHS also recommends that you consider the risks to participants. Are those with the highest risk of getting seriously ill participating? Will people be in close physical proximity to one another? How long will people be in contact with each other? Post Meetings: The most important consideration before attending a Post meeting is to stay at home if you are ill. When holding Post meetings, personal hygiene should be your utmost priority. It is recommended that you stay out of the CDC defined close contact range of 6 feet from other members to avoid any potential spread of asymptomatic individuals. These measures could include having tables or chairs spread out as far as needed in your meeting place. Also at meetings, and in general, you should avoid handshakes and personal contact with your comrades. Please consider using Zoom or Skype (video-conferencing) in accordance with the National By-Laws so Post members can attend meetings remotely.

**Sanitizing:** A Princeton University study found that COVID-19 can last up to 3 days on plastic and stainless steel. This means that *sanitizing common areas* of VFW Posts and members' homes is essential. CDC recommends household bleach solutions, alcohol solutions of at least 70% and most EPA registered household disinfectants to disinfect areas, items, and surfaces.

**Personal Hygiene:** Now more than ever, members should be practicing the best personal hygiene techniques. The simple and most basic way to do that is *hand washing*. Wash your hands with soap and warm water for 20 seconds (sing the Happy Birthday song)! You should be washing your hands or using alcohol-based hand sanitizer as often as possible. If you have to cough or sneeze, do it into a tissue and throw it away, or if none are available, look away and do it into the crease of your elbow. If you have a chronic cough or sneeze, wear a protective mask if available. *Avoid touching your face with unwashed hands*.

I am publishing this to help spread information to Wisconsin VFW members and loved ones. This information is updated daily as doctors and scientists discover more about the coronavirus. Please visit and monitor the websites above for more detailed information.

As with any health matter, please consult your doctor with any personal medical concerns. I wish you all health and happiness through this tough time.

# Memo from National Secretary-Treasurer Ann Panteleakos

Please see the memo from National Secretary-Treasurer Ann Panteleakos regarding meetings and the business of the Organization in relation to the Coronavirus (COVID-19) below.

This memo was sent to Officers of local Auxiliaries, Districts, County Councils and Departments.

Please contact your corresponding President, Secretary or Treasurer with any questions you may have regarding the information below.

### Communication is key!

As you know Coronavirus has hit all 50 states. The severity varies from state to state. We sent out an email to Department Presidents and Secretaries to share with Auxiliaries about conducting Auxiliary business. Now we are following that up with some guidelines that can be used by all for a longer period of time.

A) If you can hold your April meeting, nominate and elect Officers and Delegates please do so. You can also install at this meeting if you would like. (Be proactive)

B) If you need to cancel your April meeting but can have your May meeting, you can nominate, elect and install in May.

C) If you can't meet in April or May you have two choices:

1. Per order of the National President, if your Auxiliary agrees, you can have a virtual meeting without having 5 members in one location. You must have a quorum to hold the meeting, but the members can be in different locations. You must make every effort to notify your members of this meeting change.

2. Your current Officers will remain in office until the virus is clear and you may then have your elections at that time.

D) If your Post home is closed, you can meet elsewhere i.e. someone's house. Since we are being warned about large gatherings, some could attend in person with others by phone or Skype, whatever is available to you. Or you can postpone until the Post is open and you can hold your meeting there. We will not put you on suspension for not electing or installing Officers, or for not holding 10 meetings this year due to the virus.

E) Don't stress over deadlines. If your audit is late because you can't get the members together to do this, then it's late. If your previous 3 audits are in, we are asking Departments not to penalize them for voting at the Department Convention. We need to be flexible at this time.

This is an unprecedented time in our country and in our world. We need to remember to be flexible, kind and above all, safe and healthy.

The VFW Auxiliary National Headquarters office will be closed Monday, March 23 – Friday, April 3. We plan to reopen Monday, April 6. We will be doing most of our work remotely.

# **VETERANS LEGISLATURE AND NATIONAL NEWS**

## VA Making Adjustments to MISSION Act During COVID-19 Pandemic:

VA is not pausing the MISSION Act. The department is ensuring the best medical interests of veterans are met by adhering to the law in a manner that takes into account whether referrals for community care are clinically appropriate during the COVID-19 outbreak. VA is taking the following steps in order to ensure the safety of veterans as they access care: VA community care referrals for emergent or urgent clinical needs will continue as necessary.

- Veterans with care currently scheduled in the community should continue with this care as clinically appropriate and if available.
- Referral requests for non-emergent care with community providers will be reviewed on a case- by-case basis for immediate clinical need and with regard to the safety of the veteran when being seen in-person, regardless of wait time or drive time eligibility.
- VA is expanding the use of telehealth and telephone sessions to address many of veterans routine medical needs.

"We understand the need for community providers to halt inperson, non-emergent care to veterans, and all patients for that matter, in order to lessen the curve of this virus sweeping our nation," said VFW Washington Office Executive Director B.J. Lawrence. "Many private health care providers around the country are being forced to make similar difficult decisions, but ultimately decisions that keep the overall safety of all patients in mind. Vigilance is required in slowing this coronavirus pandemic. The Department of Veterans Affairs is taking the correct approach in handling this matter but it remains vital that many of our veterans are able to still receive the care they require. Telehealth and telephonic medical sessions are good adjustments to current conditions but VA must make accommodations for veterans who are unable to access these means of care."

### VFW Testifies on VA Debt Collection Practices:



VFW National Veterans Service Deputy Director Michael testified before the Figlioli Affairs House Veterans' Subcommittee on Oversight and Investigations on VFW-supported H.R. 5245, Stopping Implementing Harm and Enhanced Lead-time for Debts for Veterans Act, or SHIELD for

Veterans Act. Figlioli stressed that although the bill is about "debt", it is really about the Veterans Benefit Administration's internal business practices causing unnecessary stress for our nations veterans. Figlioli stated, "Veterans and the VFW understand that debts must be repaid. What we all fail to understand is how and why the burden almost always falls on the veteran, particularly when it was created by VA's lack of timeliness."

# Student Veteran Housing Bill Passes:

The House and the Senate passed S. 3503, a bill to make sure student veterans impacted by the COVID-19-related closures would not see a decrease in their monthly housing stipends. Due to most classes around the country converting to online instruction for the remainder of the semester, VA determined those students should receive the "online only" housing rate, which is significantly less money each month. Veteran advocates and Congress swiftly stepped in to make sure students using distance learning due to the outbreak would not be affected. The bipartisan, bicameral bill quickly passed the House and Senate and is now headed to the president's desk to be signed into law. The VFW thanks all the representatives and senators who made sure student veterans and their families are taken care of during this difficult time.

### Senate Passes Legislation to Expand Access to Tele-Hearings:

Last month, the Senate passed VFW-supported H.R. 4771, the VA Tele-Hearing Modernization Act. This important legislation would permit appellants in disability compensation cases before the Board of Veterans' Appeals (BVA)



to appear remotely by picture and voice transmissions, also known as "tele-hearings," from locations other than VA facilities. Currently, veterans may appear via tele-hearing from one of roughly 65 locations in BVA cases. This legislation would undoubtedly improve access for veteran appellants in disability compensation cases and would permit a greater number of veterans to attend their own hearings. The bill passed the House in November and now heads to the president. The VFW urges the president to swiftly sign this important legislation.

### U.S. Navy to Allow Enlistment Extensions and Veteran Re-Entry Due to COVID-19:



The Navy released a memo authorizing enlistment extensions and re-entry opportunities. In an effort to keep the fleet manned, the Navy is offering waivers and monetary incentives for many enlisted and officers to extend their careers. The Navy is also opening up for separated enlisted and officers to return to active

duty. While the Navy would like recently separated sailors, they encourage all former sailors who are interested to contact a prior enlisted or officer recruiter.

# Agent Orange

### VFW Commander-in-Chief Brings Veterans' Voices to Congress:

Veterans of Foreign Wars National Commander William "Doc" Schmitz called for "accountability for failure to grant benefits to Vietnam and Post-9/11 veterans suffering from toxic exposures" during a special joint hearing of the Senate and House Committees on Veterans Affairs. The VFW expressed its frustration with the Department of Veterans Affairs' lack of urgency in providing benefits to individuals who suffer from conditions associated with toxic exposures, especially when there is science to back up veterans' claims. "The VFW proposes a permanent, comprehensive, and evidence-based framework of granting presumptive benefits for toxic exposure," said Schmitz. "Veterans who were exposed to burn pits and now suffer from pulmonary conditions and rare cancers should not have to wait decades for benefits – like Vietnam veterans did." Schmitz reminded committee members that the VFW has led or played a major role in every reform or expansion of veterans benefits since the institution of the VA.

### Legislation Introduced to Add New Presumptive Diseases for Agent Orange Exposure:

Senator Tester (D-MT) introduced VFW-supported S. 3444, the Fair Care for Vietnam Veterans Act of 2020. This important legislation would expand the list of presumptive conditions associated with Agent Orange exposure to include parkinsonism, bladder cancer, hypertension, and hyperthyroidism. "Vietnam veterans did our part," said VFW Commander-in- Chief William J. "Doc" Schmitz. "After winning every battle they fought while they were in Vietnam, many of them have lost their fight to the horrible health conditions they received from Agent Orange exposure. It's unacceptable that the list of conditions presumed to be associated with Agent Orange exposure does not include bladder cancer, Parkinson-like symptoms, hypertension, and the other conditions that the scientists have said are connected to military service. The VFW is proud to support the Fair Care for Vietnam Veterans Act of 2020, which would correct this wrong."

# **Retired VA Health Care Workers Are Called to Serve:**

With the Office of Personnel Management (OPM) approval, VA announced this week that they are inviting retired physicians, pharmacists, nurses, laboratory technicians, respiratory therapists, and other medical professionals to consider coming back to VA during the COVID-19 pandemic. Opportunities are



available in Tele/ Virtual Care, the National Call Center, and Direct Patient Care/Support. VA is asking that interested individuals register online so that the individual can be matched with a VA location according to the individual's profession, location, and interest. Read more. ### Legislation Introduced to Modernize Service-Disabled Veterans Insurance:



Representative Mike Bost (R-IL) and Representative Kathleen Rice (D-NY) introduced VFW- supported H.R. 6013, the Veteran Families Financial Support Act. This important legislation would increase the maximum payment under the Service-Disabled Veterans Insurance (S-DVI) program from \$10,000 to \$40,000 and extend eligibility beyond the current two-year period after a veteran receives notification of a new service-connected disability. "The current payment amount of \$10,000 under the Service-Disabled Veterans Insurance program does not cover the rising cost of end-of-life expenses," said VFW National Legislative Service Associate Director Matthew Doyle. "The VFW is proud to support this legislation, which would increase the coverage amount of Service-Disabled Veterans Insurance and expand eligibility beyond the current two-year window after a veteran receives notification of a new service-connected disability. The VFW thanks Rep. Bost and Rep. Rice for introducing this legislation and for their efforts to expand disability benefits for veterans."



### What You Need To Get Started

- · An internet connected computer, laptop, or mobile device
- · Your meeting ID #
- · A webcam, computer microphone, headset or ear buds (if you're participating with a laptop)
- · A phone (if you're unable to receive audio via your computer, laptop, or device)

### How to Launch Zoom and Participate in Your Meeting

When you're invited to participate in a Zoom meeting, you'll receive instructions similar to what you see below. You can either click on the link provided, or go to the Zoom web site at <a href="http://swarthmore.zoom.us/">http://swarthmore.zoom.us/</a> and click on "Join a Meeting" where you can enter the 9 or 10-digit Meeting ID number. Audio is integrated in the meeting. However, you have the option to participate via audio-only if a web connected device is not available.



### While You're Waiting for the Meeting to Begin

You'll be presented with the following screen if the host hasn't started the meeting at the time you join. We recommend that you check your audio settings while waiting for the meeting to start.

Furthermore, we recommend that laptop users participate with a headset to avoid audio feedback.

### Join By Computer Audio

Once you join the meeting you will be asked whether you want to join using your computer audio or join by using your phone.

If you're using your computer microphone you MUST click the green button to join audio by computer. No one on the call will be able to hear you until you click this button.

If for some reason you do not see this window pop up, look for the small green arrow on the bottom left in the tool bar asking you to Join Audio.

If your computer does not have a microphone you can join by phone using the toll number given to you in the invite.

### The Zoom Menu Bar

The Zoom menu bar appears at the bottom of the Zoom window once the meeting begins. If you don't see the menu bar, move your mouse slightly and the bar will appear. (The bar disappears after a few seconds when in full-screen mode.)



You can:

- 1. Mute/unmute your microphone
- 2. Choose your microphone settings
- 3. Mute/unmute your video camera
- 4. Select video settings
- 5. Invite more people to join by email, IM, SMS (mobile users)
- 6. View a list of participants
- 7. Share your screen (everything you have open) or select a specific application to share (e.g., Microsoft Excel)
- 8. Send a chat message to one person (private chat) or to all participants
- 9. Record the meeting (Host only, unless you have been granted permission)
- 10. Leave or end the video meeting

### Audio and Video Mute and Unmute

During a session you might be asked to mute your microphone until you have a question or comment. This helps to minimize background noise and audio feedback. Mute your audio by clicking on the microphone icon located in the lower left-hand corner of the menu bar. You can mute your video by clicking on camera icon as well.



### **Audio Settings**

By clicking on the small carrot next to the microphone icon, you can choose your microphone and speaker settings. It normally defaults to your built-in microphone and speakers but you can select any other microphone or speakers you have plugged in to your computer.




### **Video Settings**

By clicking on the small carrot next to the camera icon, you can choose which video camera you want to use.



If you click on Video Settings at the bottom it will show you what the camera image actually looks like so you can make adjustments.



### **Testing Your Speakers**

By clicking on the audio icon you can test your speakers to make sure they are working and you can hear others. Once you click on the "Test Speaker" button music will play through your speakers until you press stop. If you do not hear music playing please make sure you have the right audio output selected in the drop down menu to the right.

You can also select your microphone from the drop down menu and see your microphone input level.

### Switching Between Views (Share Screen and Video)


As a participant you might be asked to share your desktop or an application. During a meeting you can switch back and forth between sharing your screen and sharing your video as often as needed.

### If you are displaying your screen, switch to camera video by:


1. Clicking "Stop Share" from the sharing/annotation menu at the top of the screen:
